Government Contract Provisions from the Federal Acquisition Regulation (FAR) for Subcontracts/Purchase Orders under a U.S. Government Prime Contract

- 1. When the materials or products furnished are for use in a U.S. government prime contract or subcontract, in addition to the General Provisions, the following provisions apply, as required by the terms of the prime contract or by law or regulation. The effective version of each FAR and DFARS provisions hall be the same version as that which appears in Buyer's Prime Contract, or higher tier subcontract under which this Order is a Subcontract. In the event of a conflict between these FAR provisions and the General Provisions, the FAR provision shall take precedence.
- 2. The following clauses set forth in the FAR and DFARS in effect as of the date of the prime contract are incorporated by reference. In all clauses listed below, the term "Government", "Contracting Officer", and "Contractor" shall be revised to identify the contracting parties herein and effect the proper intent of the provision excerpt where further clarified below. "Subcontractor", however, shall mean "Seller's Subcontractor" under this Purchase Order.
